C. Self-Care

I will be out the last week in October and will not be in worship on October 29. Leslie may offer a message that Sunday as part of the Because OF You series.

I am also participating in an online series of group spiritual direction and coaching through Austin Seminary, called "The Art of Well Being." "This course is designed for leaders who wish to optimize personal



wellbeing so that positive energy and creativity are supported and sustained, even in times of disruption and turbulence. Wellbeing is about a flourishing life. The course we will share together is an invitation to flourish in all of life

The course consists of six 90-minute group coaching sessions (every other Thursday) and two 50-minute one on one sessions. Faithful leaders in ministry participate in

facilitated peer conversations around significant themes related to holistic wellbeing, i.e., spiritual, mental, emotional, physical, and relational health."

D. Ministry Update

1. Care

We are seeking a leader to coordinate the Care Ministry and carious volunteers. Although we recognize that a great deal of community care happens organically, it is our belief that being more intentional about offering support, training, and community among those who participate in the Care ministry will be a good thing. We also want to ensure that people do not "Fall Through the Cracks."

2. Faith Formation

We are prayerful that the Fall Festival on October 21 will help deepen the connections among current FCCW families as well as others in the community. As our Family and Children's ministry continues to struggle post-Covid, we are exploring alternative activities and models as part of the planning process.

We continue the conversation around confirmation and are exploring curriculum. There are several referenced on the SNEUCC website, most take a more traditional approach and were developed for other denominations. There is one that we found that I have asked Debby Kirk about as it was not on the SNEUCC comparison list, but has a UCC-specific version and, as the title suggests, takes a more open way of exploring faith questions. There is also an adult version of the curriculum as well.

Adult Tuesday bible study continues, thanks to Sam Lyman's leadership.

3. Faith In Action

Faith In Action team are working on allocating the grant monies.

We will work with Stewardship to create part of the Because of You display board and to launch during this Because of You series/campaign.

And we will be launching three Google Groups to foster collaboration in conjunction with the series:

4. Worship

Creative Worship Meets 2nd Tuesday at 7pm Music/Choir will meet on select Thursdays.

Although there is potential in our ministry given the many talented musicians and singers, we have many challenges as well. As the Vision team identified as part of the Value process, the congregation has a cultural aversion to engaging in conversations to work through questions and differences. The worship team is representative of the congregation and this competing priority continues to challenge attempts to create a collaborative, team-based ministry.

1. **Draft 0.7 Communications Guidelines**

All comments and suggestions to date have been integrated into an updated draft version of the Communications Guidelines. With the board's approval of the policies (section II of the document), the draft will be sent to all teams, leaders and staff; and reviewed in meetings in the coming month to ensure awareness and seek further comments and/or clarification.

We continue to update the communication guidelines as needed, e.g., refining the newsletter due dates and content, documenting office procedures, and listing items to encourage self-review of content by content creators, including the Communications Coordinator.

PLEASE add to the Google document or send by email editable copy, i.e., text, email, word. PDFs and pictures of article text/copy is difficult to work with and makes it hard to format the overall paper and electronic newsletter.

In addition, PLEASE, PLEASE keep articles brief. If you have a lot of text, we should create a web page that we can point people to, or should send a separate focused email. There are the reasons for this, for paper newsletters our goal is 10 printed pages or less to avoid extra postage, for the online newsletter google/Gmail has started clipping (truncating) really long emails, and for both newsletters people tend to scan through the articles and pull out read what seems appealing – and too much text is more likely to turn people off.
