First Congregational Church of Woodstock Operating Fund Financial Comments – Year to August 31, 2025

Summary

• The budget report continues to show we are trending better than budget. Operating net revenues of \$118.6k were almost fight on budget (budget: \$118.1k). Actual net expenses of \$107.7k were \$18.7k below budget (budget: \$126.4k). Net operating income was \$10.9k, a positive variance of \$19.2k vs. budget (budget was loss of \$8.3k).

Differences vs. budget:

- Pledges are right on budget.
- Chicken BBQ details are not finalized. However, it is believed that the final results will be close to budget.
- We continue to have savings from open or delayed filling of positions. The delayed filling of the Communications Coordinator position has yielded YTD savings of \$6,476 vs. budget. The unfilled Children and Family Coordinator position has yielded savings of \$6,032 vs. budget. The unfilled accompanist position has yielded savings of \$4,000 vs. budget.
- The Facilities accounts continue to have a positive variance (total \$6,765), largely due to recurring maintenance and minor repair accounts. This positive variance has shrunk slightly, and is likely to continue to shrink as the unpredictable timing of these expenses is incurred.
- Daycare Rental is right on budget; Room and use revenues of \$2,195 are \$195 below budget.
- Investment income of \$12,546 is \$1,146 above budget of \$11,400, due to slightly higher interest rates than forecasted.
- There were no other material differences vs. budget.
